

#### Susan Whiting, Chair of the Board



Susan Whiting is recognized as a leading expert in consumer behavior, audience measurement, media research and information services. She currently serves as a board director and executive advisor to for-profit global companies, both private and public, as well as advising VC backed and start-up companies. Ms. Whiting currently serves on the board of directors for Alliant Energy Corporation, DJE Holdings, Moxie Software and PageVault. She is also an advisor to Continuity Logic and a member of Hyde Park Angels.

Ms. Whiting has decades of experience as a volunteer leader and board member for not for profit organizations. Most notably, she serves as Board Chair of The National Women's

History Museum in Washington, DC and a board trustee for the Chicago Academy of Sciences' Peggy Notebaert Nature Museum, which she recently chaired, and as a trustee for The Trust for Public Land and Denison University from which she graduated.

In the past, Ms. Whiting has also served on numerous boards including The YMCA of Greater New York, the corporate fund board of The Kennedy Center for the Performing Arts, Wilmington Trust and MarkMonitor.

She most recently served as vice chair of Nielsen, the largest global research company, measuring what consumers watch and buy, with responsibilities overseeing global communications & marketing, corporate social responsibility, public and government affairs, diversity and inclusion and client engagement. Prior to this, she served as President and CEO of Nielsen Media Research, the television ratings division, for part of her tenure at Nielsen. Ms. Whiting retired from the company in January 2014, after a 35-year career. Ms. Whiting is best known for building Nielsen's most visible franchise in television measurement during the cable, telecommunications and media industries' digital transition.

Ms. Whiting is also currently a member of the national performing arts committee for the John F Kennedy Center for the Performing Arts, the Tiffany Circle of the American Red Cross of Greater Chicago, the International Women's Forum, the Economic Club of Chicago and The Chicago Network. In addition, she is involved in mentoring female business leaders around the world. After residing in New York City for decades, she now resides in Chicago, Illinois. She is a cousin of Susan B. Anthony and is dedicated to the advancement of women and gender equality.



# Gretchen Green, MD, MMS | Vice Chair of the Board



Gretchen E. Green, MD, MMS is an attending radiologist at Greensboro Radiology in Greensboro, NC, specializing in women's imaging. She earned an undergraduate degree in Neuroscience, Master of Medical Science in the history of medicine and pharmacology, and a Doctor of Medicine degree with honors from Brown University. While serving as Chief Resident in diagnostic radiology at Yale, she was awarded the national Lucy Frank Squire Distinguished Resident Award and the RSNA Roentgen Resident/Fellow Research Award. She has co-authored two acclaimed medical textbooks on breast imaging with colleagues at Brigham and Women's Hospital, Harvard Medical

School: Diagnostic Imaging: Breast and Specialty Imaging: Breast MRI. A Comprehensive Imaging Guide.

Dr. Green has been actively involved in advocacy for women physicians and patients since 1992 through research on the history of medicine and involvement with the American Medical Association's Women Physicians Congress. She has lectured nationally on women's imaging topics as well as the history of women in medicine. Her research on the history of women in medicine and history of obstetrical anesthesia has won numerous awards, including second place at National History Day and Illinois Student Historian of the Year. She has since served as a judge at National History Day, evaluating the website category.

Since joining Greensboro Radiology in 2006, she has served on the Cone Health Regional Cancer Center cancer committee, Cone Health Credentialing Committee and the Greensboro Breast Cancer Working Group. She has served as medical director of ultrasound for Greensboro Radiology and medical director of mammography at Morehead Hospital in Eden, NC.

In July of 2013, she received the Alumni Distinguished Leadership Award from the Illinois Mathematics and Science Academy.

Dr. Green lives in Greensboro, North Carolina with her husband and two children.



## Ann E. W. Stone, Secretary



Ann Stone is a Founding Board member and one of three original incorporators of the National Women's History Museum. She was also an integral part of the campaign by the Museum to pass legislation and raise money to move the "Portrait Monument" (the statue given by the suffragists to the Congress to celebrate the passage of the 19th Amendment) out of the Crypt of the Capitol and into the Rotunda. She actually negotiated the terms for the move.

Ann Stone is also the founder and president of The Stone Group, Inc., an award-winning direct marketing business. Ms. Stone has founded other businesses and helped launch

a national bank. She serves on the boards of Empowered Women International and The Washington Center (Women as Leaders). She is the past Chairman of the Alexandria branch of the American Heart Association and was an officer of The Association of Direct Marketing Agencies (ADMA) and serves on a variety of other Boards and Commissions. She was chosen by the Governor to serve on the last Board of Historic Preservation for the state of Virginia before it was folded into the Association for the Preservation of Virginia Antiquities (APVA). She co-hosts a local public affairs TV show, *Alexandria Forum*, in Alexandria Virginia and has published a host of articles and op ed pieces on a variety of topics.

Ms. Stone speaks professionally in the United States and overseas on such topics as entrepreneurship, politics, women's history, women's issues, and much more. She has been listed in the Who's Who of Marketing and Advertising Executives and the International Edition of Who's Who as well as Outstanding Women in America. In 1992, she was chosen as one of 75 Women Who Changed Politics in America by C&E Magazine. ## Joan Wages, President & CEO



As president & CEO of the National Women's History Museum (NWHM), Joan Bradley Wages leads the 501(c)3 nonprofit organization dedicated to educating Americans about the diverse, historic contributions of women and raise awareness about the critical need for a national women's history museum in our nation's capital. As one of NWHM's founding Board Members, Joan has been a passionate and tireless champion of this effort for nearly 20 years. She advocated Congress to pass current legislation that established a bi-partisan Congressional Commission to produce a feasible plan for the Museum,

which the President signed in December 2014.

Prior to her current position, Joan championed women's issues on and off Capitol Hill throughout her career. Joan began her career in the airline industry as a flight attendant for Trans World Airline, and later served as Director of Customer Service for the airline, eventually joining the Independent Federation of Flight Attendants as its spokesperson and lobbyist. She teamed with a small group of women to advocate for the transfer of The Portrait Monument from the Capitol Crypt to the Rotunda, where it stands today. Joan served as president of Cash, Smith & Wages, where she helped pass the Family and Medical Leave Act, the smoking ban on aircrafts, numerous aviation security measures, and Delaware legislation to prevent the take-over of corporations by corporate raiders. Joan has participated in Women in Government Relations and the Women's Leadership Forum. She also served on the Board of the Virginia Alliance for Health Care Freedom.

As part of its Remarkable Women series, Lifetime Television honored Joan for her efforts on behalf of the Museum. She has a TEDx Talk on *Where Are Our Heroines?*. Ms. Wages holds a B.A. from Auburn University and an M.A. in Philosophy from Columbia Pacific University.



## Catherine "Cat" Allgor



Catherine Allgor is the Nadine and Robert Skotheim Director of Education at The Huntington Library, Art Collections, and Botanical Gardens in San Marino, CA, and is a Professor of History and UC Presidential Chair at the University of California, Riverside. She attended Mount Holyoke College as a Frances Perkins Scholar and received her Ph.D. with distinction from Yale University, where she also won the Yale Teaching Award.

Allgor began her teaching career at Simmons College and has been a fellow at the Radcliffe Institute for Advanced Study and a Visiting Professor of History at Harvard

University. Her dissertation received a prize as the best dissertation in American History at Yale and The Lerner-Scott Prize for the Best Dissertation in U.S. Women's History.

Her first book, *Parlor Politics: In Which the Ladies of Washington Help Build a City and a Government* (University Press of Virginia, 2000), won the James H. Broussard First Book Prize from the Society for Historians of the Early American Republic and the Northeast Popular Culture/American Culture Association Annual Book Award. Her political biography, *A Perfect Union: Dolley Madison and the Creation of the American Nation*(Henry Holt, 2006), was a finalist for the George Washington Book Prize. In 2012, she published *Dolley Madison: The Problem of National Unity* (Westview Press) and *The Queen of America: Mary Cutts's Life of Dolley Madison* (University of Virginia Press). President Obama has appointed Allgor to a presidential commission, The James Madison Memorial Fellowship Foundation.



## Molly Bordonaro

Jon S. Jon also advised Congresswoman Norton on all economic development issues, including passage of TIF and revenue bond financing for the District of Columbia; an act to allow the issuance of bonds to construct the District's new convention center; the Southeast Federal Center Public-Private Development Act; authorization to construct the Bureau of Alcohol Tobacco, Firearms and Explosives headquarters in Washington, DC; funding to build the New York Avenue Metro stop; location of the Department of Transportation headquarters and Homeland Security Headquarters in DC; and reopening Ronald Reagan Washington National Airport and keeping DC open for business after the tragic events of September 11, 2001. Jon also served as Congresswoman Norton's lead staff person in shepherding the District's annual budget through the House and Senate.

Jon is an adjunct professor of law at American University's Washington College of Law, where he taught the legislation course from 1999 to 2008. He is the current chair of DC Appleseed, former chair of DC Vote and serves on the board of the University of the District of Columbia David A. Clark School of Law and the DC Public Library Foundation. In addition, he is a past chair of the District of Columbia Affairs Section of the DC Bar. Jon is a member of the District of Columbia Federal Law Enforcement Nominating Commission that recommends candidates for the US District Court, US Attorney, and other federal agencies, and he is a member of the District of Columbia Access to Justice Commission. Jon also is a Trustee of the Federal City Council.

Susan Scanlan helped found the Congressional Caucus for Women's Issues and its policy arm, the Women's Research & Education Institute (WREI). At that time, there were 17 women in the House of Representative and one woman in the Senate. Today, the Caucus has grown to 76 Congresswomen and 18 Senators—from 4 to 17 percent of Congress. Ms. Scanlan served as director of the Caucus for five years before taking leadership of WREI's Congressional Fellowships on Women & Public Policy. Since 1980, this program has placed over 300 talented scholars on Capitol Hill for eight months of hands-on training in how federal

Ms. Scanlan began her career on Capitol Hill as legislative director for Rep. Charles Wilson, where she helped author legislation that admitted women to the U. S. military academies and established March as Women's History Month. From 1991-1998, Ms. Scanlan pursued career opportunities in Asia with her husband, Jared Cameron. There she taught, edited, learned Mandarin, and wrote monthly magazine columns. Upon her return to the States, Ms. Scanlan rejoined WREI as its president. In November 2005, she was elected chair of the National Council of Women's Organizations, a coalition of over 230 progressive women's groups representing more than 12 million American women. She is a Phi Beta Kappa graduate of Sweet Briar College and holds a master's degree in modern languages from Tulane University.

# Wilma L. Vaught, Brigadier General USAF Ret.



General Wilma Vaught is one of the most decorated military women in U.S. history. During her military career, General Vaught held various positions in the comptroller field all over the world, from Spain to Vietnam to Dayton, Ohio. She was Deputy Chief of Staff in Maryland. Her last military assignment was as Commander of the U.S. Military Entrance Processing Command, North Chicago, Illinois.

She served as Chairperson of the NATO women in the Allied Forces Committee from 1983 to 1985 and was the senior woman military representative to the Defense Advisory Committee on Women in the Services from 1982 to 1985.

Due to General Vaught's efforts, the nation's first major national memorial to honor women who served in our nation's armed forces during all eras and in all services was opened at Arlington Cemetery. General Vaught is the President of the Board of Directors of the Women in Military Service for America Memorial Foundation.

General Vaught earned a Bachelor of Science degree from the University of Illinois, Champaign-Urbana from which she received the Distinguished Alumni Achievement Award in 1983. She also holds a MBA degree from the University of Alabama, Tuscaloosa, and an Honorary Doctorate of Public Affairs from Columbia College, SC. She received the Woman Who Made A Difference Award in 1985, the Margaret Cochran Corbin Award in 2000, and was inducted into the National Women's Hall of Fame in 2000.
